Special resolution

To consider and, if thought fit, pass the following resolution as a Special Resolution:

- That, subject to Resolution 5 being passed, the Directors be empowered, pursuant to Section 570 of the Act (but without prejudice to the exercise of any such authority prior to the date hereof), to allot equity securities (as defined in Section 560 of the Act) which they are from time to time authorised to allot, as if Section 561(1) of the Act did not apply to such allotment as follows:
 - (a) in connection with an issue pro rata (including, without limitation, under a rights issue, open offer or similar arrangement) to holders of equity securities in proportion as nearly as may be to their respective holdings of such securities or in accordance with the rights attaching thereto (but with such exclusions or other arrangements as the Directors may deem necessary or expedient to deal with fractional entitlements, record dates or other legal or practical problems under the laws of any territory, or the requirements of, any recognised regulatory body or any stock exchange in any territory, or as regards shares held by an approved depositary or in issue in uncertificated form); and
 - (b) generally in connection with an issue of equity securities (other than pursuant to sub paragraph (a) above) up to an aggregate nominal amount of£1,100,000;

PROVIDED THAT:

- this authority shall expire at the earlier of the commencement of the Annual General Meeting held next after the passing of this
 resolution or 30 September 2023;
- (2) the Company maybe before such expiry make an offer, agreement or other arrangement which would or might require equity securities to be allotted after such expiry and the Directors may allot equity securities pursuant to any such offer, agreement or other arrangement as if the authority hereby conferred had not so expired.

Notes

- 1. As permitted by Regulation 41 of the Uncertificated Securities Regulations 2001 and Article 10 of the Company's Articles of Association, shareholders who hold shares in uncertificated form must be entered on the Company's share register at close of business on 28 June 2022 in order to be entitled vote at the AGM or, if the AGM is adjourned, shareholders entered on the Company's register of members not later than close of business on the date two days prior to the adjourned meeting shall be entitled to attend and vote at the AGM in respect of the number of shares registered in their name at the time. In each case, changes to the register of members after such time shall be disregarded in determining the rights of each person to vote at the AGM
- 2. In the case of joint holders of a share, the vote of the senior who tenders a vote shall be accepted to the exclusion of the votes of the other registered joint holders of the share and for this purpose seniority shall be determined by the order in which the names of the joint holders stand in the register of members in respect of the share.
- 3. Anycorporationwhichisamembercanappointoneormorecorporaterepresentatives who may vote as a member provided that they do not do so in relation to the same shares.
- 4. To appoint the chairman of the meeting as your proxy using the proxy form, the form must be:
 - · completed and signed;

 - received by the Company's registrars no later than 1.30 p.m. on 28 June 2022

CREST members who wish to appoint a proxy or proxies through the CREST electronic proxy appointment service may do so for the Annual General Meeting to be held on 30 June 2022 and any adjournment(s) thereof by using the procedures described in the CREST Manual. CREST personal members or other CREST sponsored members, and those CREST members who have appointed a voting service provider should refer to their CREST sponsors or voting service provider(s), who will be able to take the appropriate action on their behalf.
